Personal data that we process

Mc'bedded processes your personal data because you use our services and / or because you provide these to us yourself.

Below you will find an overview of the personal data that we process:

- First and last name
- Gender
- Address data
- Telephone number
- E-mail address
- IP address
- Information about your activities on our website
- Bank account number

Special and / or sensitive personal data that we process

Our website and / or service does not intend to collect data about website visitors under the age of 16. Unless they have permission from parents or guardian. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children,



to prevent data about children being collected without parental consent. If you are convinced that we have collected personal information about a minor without that permission, please contact us via info@mcbdedded.nl and we will remove this information.

For what purpose and on what basis we process personal data

Mc'bedded processes your personal data for the following purposes:

- Handling your payment
- Being able to call or e-mail you if this is necessary to be able to perform our services
- Inform you about changes to our services and products
- To deliver goods and services to you

Automated decision making

Mc'bedded does not make decisions on the basis of automated processing on matters that can have (significant) consequences for people. These are decisions that are made by computer programs or systems, without a human being (such as a Mc'bedded employee) among them.

How long we keep personal data

Mc'bedded does not store your personal data for longer than is strictly necessary to achieve the purposes for which your data are collected. For visitors to the website and customers of Mc'bedded, we offer the possibility to view, change or delete the collected data. For the removal of data, this is also legally permitted. Those who wish to make use of these offered options are requested to contact Mc'bedded via the aforementioned channels.

Sharing of personal data with third parties

Mc'bedded does not sell your information to third parties and only provides it if this is necessary for the implementation of our agreement with you or to comply with a legal obligation. We enter into a processing agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. Mc'bedded remains responsible for these processes.

Cookies, or similar techniques, we use

Mc'bedded uses only technical and functional cookies. And analytical cookies that do not infringe on your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and, for example, remember your preferences. We can also use this to optimize our website. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information that was previously saved via the settings of your browser.

View, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent for data processing or to object to the processing of your personal data by Mc'bedded and you have the right to data transferability. This means that you can submit a request to us to send the personal data that we hold about you in a computer file to you or another organization mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to info@mcbdedded.nl.

To ensure that the request for inspection has been made by you, we request that you send a copy of your proof of identity with the request. Make in this copy your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen service number (BSN) black. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks.
